I acknowledge and agree that by completing and signing this Consent, I am authorizing FinanciaLinx/CrédiLinx and the dealer to collect, use and disclose my personal information, including my Social Insurance Number ("SIN") if I choose to provide it, in accordance with the terms of this Consent. If provided, my SIN will be used to verify my identity and match credit reports.

I authorize dealer to disclose my personal information to FinanciaLinx/CrédiLinx in order that FinanciaLinx/CrédiLinx may: (i) evaluate my application for the financing or lease of a vehicle; (ii) upon executing the financing or lease contract, monitor, record and determine my compliance with my obligations; (iii) answer my questions and provide customer service; (iv) administer and manage its business operations, including process payments, manage, administer, collect and enforce accounts, meet legal, regulatory, insurance, security and processing requirements, defend and bring legal actions, and maintain records for reasonable periods; (v) promote products or services to me, unless I opt-out; and (vi) otherwise use it as permitted or required by law (collectively, herein after referred to as the "Purposes"). Unless I opt-out, FinanciaLinx/CrédiLinx may disclose my personal information to its affiliates so that they may provide me with information and special offers that may be of interest to me.

I further authorize dealer and/or FinanciaLinx/CrédiLinx to disclose my personal information (including financial information) to the automotive manufacturer of the vehicle selected by me and forming the subject matter of the financing or lease contract ("Manufacturer") and the Manufacturer's authorized dealers in order that they may: (i) meet safety, security, legal and regulatory requirements, including with respect to potential recalls; (ii) maintain accurate records to respond to my inquiries and provide me with warranty or other customer service communications, and otherwise better understand and manage their relationship with me; (iii) satisfy other reasonable, legitimate business interests; and (iv) unless I opt-out, provide me with general marketing, product, service and business partner information and offers, including end of financing or lease offers and re-marketing of my lease terms, if applicable.

Any file relating to me and retained by FinanciaLinx/CrédiLinx will be kept at one of its or its affiliates' offices and will be accessible by FinanciaLinx/CrédiLinx's authorized employees and service providers.

I understand that my rights with respect to my personal information held by dealer and FinanciaLinx/CrédiLinx are as set out in each of their respective privacy policies or statements and include my right to request access to or correction of the personal information in my file, to the extent provided by law.
